KRD-IG announcement on the activities of extremist groups of foreign influence destabilizing the industry

The poultry industry in Poland plays a significant role in the national economy, offering high-quality products to consumers in the country and around the world, as well as creating numerous jobs. Unfortunately, our sector has recently been targeted in what appears to be an organized attempt at destabilization. These activities are carried out by extremist groups associated with the former leader of Partia Przebudzonych Konsumentów (The Awakened Consumers Party). Media reports describe this former party as an openly pro-Russian group (https://www.rp.pl/polityka/art37835271-tajne-finanse-prorosyjskiej-partii).

An analysis of the activities of the extreme group shows that it is involved in extensive communication activities, using social media platforms to spread negative opinions about the poultry industry. These actions, based on disinformation, appear to be coordinated with the aim of spreading distrust towards the entire poultry sector in Poland.

In recent days, aggressive messages, threats against breeders and industry employees, and mass sharing of negative content against the poultry industry have become a characteristic element of their activity. Such actions may negatively impact the reputation of the poultry sector, which in turn may weaken the trust of consumers and trading partners. Spread of disinformation and aggressive rhetoric may also lead to social tensions, which may destabilize the market stability of the sector.

Recommendations: KRD-IG recommends that the entire industry remains vigilant in the face of the described activities and is prepared to communicate with the media and the community to clarify facts and refute disinformation. This is a priority to minimize the potential negative effects of these activities and ensure the durability and stability of our industry in the face of destabilization attempts by these extremist groups.
